



RSGB Membership – Subscription Rates and Bankers Order.

Under the RSGB and RHS Statutes all subscriptions must be paid by 31st November each year for the subsequent year. If a member fails to meet this deadline then they must re-apply and re-pay the initial registration subscription. To help reduce late payment problems, and minimise administration, we requested that all renewal subscriptions are paid by Standing Order - for which we give a £10 reduction on the normal £89.50 annual fee.

Standing Order:

In order to reduce administration, and avoid a membership lapsing inadvertently, all members are asked to pay their annual subscription by Bankers Standing Order for which, in return, they receive a £10 rebate on the normal £89.50 annual membership fee.
